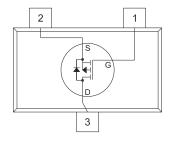

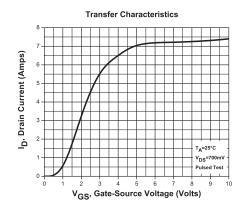


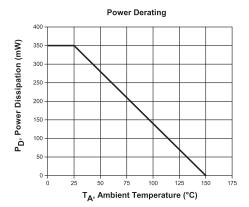
TYPICAL ELECTRICAL CHARACTERISTICS
